**Purpose:** To make a donation to a crowdfunding campaign, publish a crowdfunding campaign, be a beneficiary organization and receive funds through crowdfunding campaigns (only for NGOs), send notifications related to your actions on womeninfusion.org, and send electronic communications (email, SMS, WhatsApp) about our projects and solidarity campaigns on womeninfusion.org.

**Legal Basis:** The user's consent when registering through our registration form and checking the box accepting the Terms and Conditions, Privacy Policy, and Cookie Policy, as well as the box for receiving information.

**Retention:** Once your request has been resolved through our form or answered by email, if it has not generated a new processing activity, and if you have agreed to receive commercial communications, until you request to unsubscribe.

Contact Form:

#### Retention:

Once your request has been resolved through our form or answered by email, if it has not generated a new processing activity, and if you have agreed to receive commercial communications, your data will be retained until you request to unsubscribe.

• Email Communications

**Purpose:** To respond to your information requests, address your inquiries, and answer your questions. If you send us your CV, your personal and professional data may be included in our database for current and future recruitment processes.

**Legal Basis:** The user's consent when requesting information via email or sending their data and CV to participate in our recruitment processes.

**Retention:** Once your request has been answered via email, if it has not generated a new processing activity. If we receive your CV, your data may be retained for up to one year for future recruitment processes.

• Obligation to Provide Personal Data and Consequences of Not Doing So
